## Discover how to register and use TRACES for the veterinary and plant health sectors

Dear partner-beneficiaries,

Many agri-food products require certificates to enter the EU market. **TRACES** is the EU's online sanitary and phytosanitary certification platform that facilitates this process.

This series of webinars aims to help companies and competent authorities in low-and middle-income countries get to know TRACES: how to access it, how to monitor non-compliances, how to create and complete official certificates to the EU and tips for making the process as efficient as possible.

These webinars are led by external experts hired by the European Commission's Directorate-General for Health and Food Safety (**DG SANTE**) who will take participants step-by-step through the TRACES system. The webinars are organised as part of the **AGRINFO** programme, an EU-funded information service that keeps stakeholders informed about new and upcoming EU regulations, and how they affect agri-food and fisheries sectors that supply the European market.

There are **three webinars**, with a duration of around 1h30, each offered in multiple time zones and languages: English, French, Spanish, and Portuguese.
